Hi Keith, Thank you for time today in discussing 1409-1417 12th Street, Oakland. I originally sent an e-mail to Barbara Sieminski with the Regional Board regarding some proposed work for the site and was informed that you were lead on the case. The OSCF has received a proposal that includes excavation of some hot spot areas and the decommissioning of some DPE and ground water monitoring wells. In light of our discussion, you indicated that you were expecting some verification sampling data for soil/groundwater due to post DPE rebound from Joseph with Impact Environmental. The proposed work included the following:

- 1. decommissioning of DPE wells 1B, 3, 5 and Monitoring well #8 and GW 1 and 3.
- 2. Excavation of contaminated soil around hot spot locations (DPE 3 and GW1) Approximately 200 tons
- 3. Replace decommissioned wells DPE3 and GW1 and conduct two semi-annual ground water monitoring events.

All corrective action work proposed must be considered in light of the LTCC. Once you have had an opportunity to review the data, please verify if you concur with the proposed work.
