Alameda County Department of Environmental Health (ACDEH) staff is considering the above referenced site for potential case closure. As you are aware site investigation for hazardous substance(s) release(s) has been performed at the subject property to which you are named as the primary or active responsible party.

List of Landowners Form

ACDEH, the local agency, does not consider cleanup or site closure proposals from the primary or active responsible party, issue a closure letter, or make a determination that no further action is required with respect to a site upon which there was an unauthorized release of hazardous substances unless all current record owners of fee title to the site have been notified of the proposed action. Please complete the enclosed *List of Landowners Form* in order to certify that all current record owners of fee title have been identified. ACDEH requests the return of the *List of Landowners Form* to this agency as an electronic mail attachment (preferred), Attention: Keith Nowell, or by land mail by the date identified below.

Site Management Requirements

ACDEH staff has evaluated the case file and believes the case may be eligible for closure. Closure would be under a commercial land use scenario with a land use covenant (LUC) and site management requirements, as residual soil contamination remains in soil beneath the site. Therefore, ACDEH will require preparation of a Site Management Plan (SMP) addressing potential contaminants of concern should excavation or construction activities occur in areas of residual contamination. These activities require planning and implementation of appropriate health and safety procedures by the responsible party (or current property owner/developer) prior to and during excavation and construction activities. ACDEH requests preparation and submittal of the SMP by the date identified below.

In accordance with the LUC, re-evaluation of this case is required if land use changes to any residential or other conservative land use, or any redevelopment occurs as residual contamination is documented to remain in the soil beneath the site.

This site is to be entered into the City of Oakland Permit Tracking System due to the residual contamination on site.

Public Participation

Public participation is a requirement for the Corrective Action Plan and case closure processes. In order to notify potentially affected members of the public of the potential fuel leak case closure, *Notification of Potential Case Closure* will be distributed to addresses in the immediate vicinity. The *Notification of Potential Case Closure* requests that landowners or residents submit any comments or questions to ACDEH regarding potential case closure. ACDEH will consider all comments from the public prior to potential case closure.

Prior to distribution of the notification, please return the *List of Landowners Form* to ensure that the current landowner(s) is included in this process.

Waste Removal Activities

Following receipt of the *List of Landowners Form*, ACDEH will request confirmation that no investigation and remediation derived waste remains at the site. At this time we request that you remove any remaining investigation and remediation derived waste from the site. Please include removal documentation, if warranted, in your confirmation letter.

REPORT & DELIVERABLE REQUESTS

Alameda County Department of Environmental Health (ACDEH) Cleanup Oversight Programs, Local Oversight Program (LOP) and Site Cleanup Program (SCP) require submission of all reports in electronic form to the State Water Board's (SWB) GeoTracker website in accordance with California Code of Regulations, Chapter 30, Division 3, Title 23 and Division 3, Title 27.

Leaking Underground Fuel Tank (LUFT) Cases

Reports and deliverable requests are pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party (RP) in conjunction with an unauthorized release from a petroleum underground storage tank (UST) system.

Site Cleanup Program (SCP) Cases

For non-petroleum UST cases, reports and deliverables requests are pursuant to California Health and Safety Code Section 101480.

ELECTRONIC SUBMITTAL OF REPORTS

A complete report submittal includes the PDF report and all associated electronic data files, including but not limited to GEO_MAP, GEO_XY, GEO_Z, GEO_BORE, GEO_WELL, and laboratory analytical data in Electronic Deliverable Format™ (EDF). Additional information on these requirements is available on the State Water Board's website (http://www.waterboards.ca.gov/water_issues/programs/ust/electronic_submittal/)

- Do not upload draft reports to GeoTracker
- Rotate each page in the PDF document in the direction that will make it easiest to read on a computer monitor.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6731, 6735, and 7835) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately licensed or certified professional and include the professional registration stamp, signature, and statement of professional certification. AGENCY OVERSIGHT

Significant delays in conducting site assessment/cleanup or report submittals may result in referral of the case to the Regional Water Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.
