Want to angle bore, excavate (sic) GW, the GW is contaminated.

Explained SI process to him, identify site contaminated, define extent, then propose cleanup. They don't have extent defined, just have a few investigative borings. Olivia says there is a clay layer that stops all contamination, they drilled all the way down to 16' bgs.....I re-explained SI, contamination, etc. Bill kept talking about wanting to do the work... Clearwater says it only takes 3-6 weeks for us to respond on sites...

Told him timeframe I gave to Steve Zimmerman still holds, they will hear from CW toward end of Jan.
Rec he not implement any work unless approved by ACEH.
Told him I generally understand the work he is describing to me, however the proposal doesn't seem appropriate at this stage of the SI (limited data so far).

He said he will go back to his consultant & understand the work better & look at having a work plan submitted.
