MONITORING WELL ABANDONMENT LETTER

Dear Mr. Wickham:

We have prepared this this letter to document the abandonment of three groundwater monitoring wells (MW-1, MW-2, and MW-3) at Fire Station No. 3 in Pleasanton, California (Site).

The Site is located at 3200 Santa Rita Road in Pleasanton, California. The property is relatively level and is currently occupied by a fire station. The Site is currently an active Leaking Underground Storage Tank case (LUST) under the oversight of Alameda County Environmental Health (ACEH) (Case No. RO0002938).

The monitoring wells were abandoned on November 21, 2013 in accordance with permit #2013137 issued by the Zone 7 Water Agency. The abandonment was performed by removing the well boxes, drilling out the entire well casings and annular seals using an 8-inch-diameter auger, and grouting the borings. We have prepared well completion reports, which will be submitted to the Department of Water Resources, Central District Office. Copies of the well completion reports are attached.

We understand that the case will be closed pending the filing of this report. If you have any questions regarding this letter, please call and we will be glad to discuss them with you.


