## Hi Mark:

I hope all is well with you. I am writing this email to update you on the progress of work at 2145 35<sup>th</sup> Avenue site in Oakland. The work is proceeding according to the workplan dated June 4, 2010 and its Addendum. To date the following activities have been completed:

- Before demolishing the building onsite, a professional surveyor surveyed the corners of the building; the location of the former USTs; the location of the hydraulic lift; the location of the pit; and the dispenser island and piping locations.
- After the survey, the building onsite was demolished under a demolishing permit from the City of Oakland. The demolition materials were sent offsite for recycling and disposal
- The concrete slab was removed and sent offsite for recycling. The concrete pit and hydraulic lifts are left exposed.

The next activities before we drill the boreholes, will be to remove the hydraulic lift, car maintenance pit, and any piping left onsite. As mentioned in the workplan, I will collect soil samples from under the pit, hydraulic lift, and piping for analysis after their removal. Should water be encountered, I will also collect grab groundwater samples for analysis.

Please let me know if you want to conduct a preliminary visit to the site to discuss the above mentioned activities. Also, let me know if you want to witness the sampling after the removal of the hydraulic lift, pit, and piping. I will schedule the site activities and let you know at least 48 hours ahead of time.
