Will you let me know if there is any mechanism used by the Alameda County Environmental Health to urge the school to allow us to drill these borings? I remember in the old days, San Mateo County Environmental Health used to send a letter to the neighboring owner where drilling is needed at their property. The letter used to say if permission is not granted, the subsurface impact at their site will be their own responsibility. Just to follow up on our conversation today, I think preparing a Feasibility Study/Soil Remedial Action Plan (FS/RAP) is independent from the upcoming remaining subsurface investigation. I intend to prepare one document to include both the Feasibility Study and the Remedial Action Plan for the preferred alternative (limited soil excavation). Since obtaining approval from the Fund on the money needed for the remedial action takes considerable amount of time, please indicate in your next directive regarding the offsite borings that we can proceed with the FS/RAP. Completing the soil remedial action onsite with favorable confirmation sampling results, with your help and approval, would allow the owner to proceed with construction on the property. My plan is to complete the FS/RAP within the next 90 days. The Fund already approved the cost for preparing the FS/RAP.
