This email is regarding the Salisbury project (RO2945) at 2145 35th Avenue in Oakland. We need an extension of time to execute the tasks approved by the Orphan Fund. The requested extension is due to a delay in getting the money to prefund the project, completing the contractual agreement between Salisbury Avenue Associates, LLC (the site owner) and EEC, and change of management within Salisbury Avenue Associates, LLC regarding the subject property.
