Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

Responsible Party Identification

Existence of an Unauthorized Release

The property is located on the southwest corner of 35th Avenue and Salisbury Street in Oakland and is parcel number 27-879-15-2 with the addresses of 2145 and 2151 35th Avenue. The two addresses were vacant or used for single-family homes until approximately 1933, when an auto repair facility was located on both properties. The property was listed as Rio Grande Service Station by 1945 and Bob Moore Auto Service in 1955. In 1962 the site was designated as John Madler Chevron Service. In 1967, John Madler Automotive and Service Auto Repair is listed at 2151 35th Ave. and Standard Station is listed at 2145 35th Ave. Chevron records indicate they delivered gas to the facility (Chevron station 8861) between 1958 and 1972. 1950 Sanborn maps indicates "gas and oil" on the eastern portion of the site. A permit to remove a 500 gallon fuel oil tank was filed with the OFD in 1999, however no tank was found in the area excavated. Analytical results from one soil sample collected by the contractor were ND for petroleum hydrocarbons. Based upon interviews with Mr. James Carver, former property owner, he stated that he removed two gasoline tanks with City of Oakland oversight in 1984, however, no tank removal report was ever issued and the contractor is no longer in business. On 2/23/07 four soil samples and one grab groundwater sample was collected from locations of the former gasoline tank pit. Up to 2100 ppm TPHg, 1200 ppm TPH as stoddard solvent, 360 ppm TPHd and 27 ppm TPHmo was detected in soil samples and up to 87,000 ppb TPHg, 71,000 ppb TPH stoddard solvent, 69,000 ppb TEPH as diesel, 1800 ppb TPHmo and 250 ppb benzene was detected in the grab groundwater sample confirming a release had occurred.

Responsible Party Identification

It appears that as early as 1950 by the Sanborn map or by at least 1958, gasoline was being supplied to USTs at this site. It is unclear when the leak occurred or when the tanks were no longer in use, although there is evidence the gasoline tanks were removed in 1984.

1. John and Thelma Madler owned the property from at least 1969 to 1986, during which time the gasoline tanks were present and operating according to Chevron records, therefore, they are RPs according to definitions number 1, 2,3 and 4.
2. James and Elizabeth Carver owned the property from December 5, 1990 to January 26, 2000. They are, therefore, RPs according to definition 3.
3. David Lervan TR and Plez Middleton TR owned the property from January 26, 2000 to March 9, 2000 at which time Plez Middleton TR assumed sole ownership. Therefore the two individual trustees are RPs according to definition 3 and they have been named separately.
4. Maria Campos bought the property on March 15, 2000 and owned it until May 18, 2007. She is a RP according to definition 3.
5. Salisbury Avenue Associates, LLC bought the property from Maria Campos on May 18, 2007 and are a RP according to definition 3.
