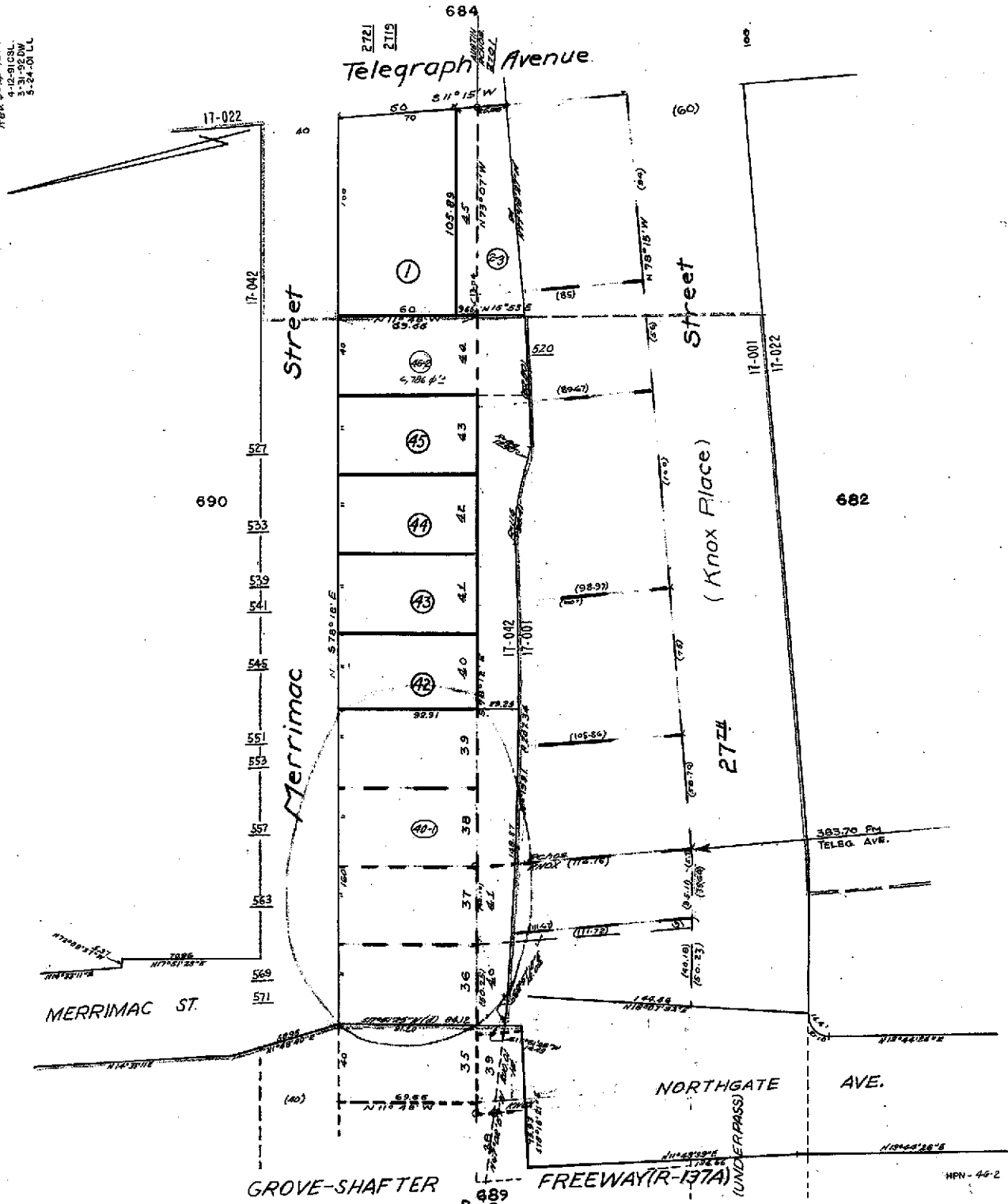
Map of the Ranchos of Vicente and Domingo Peralta, (Plot 2)
