That explains why I can't find anything. We are not the correct successor in interest to United California Bank.

The following information is taken from the National Information Center of the Federal Reserve System, which you can access at http://www.ffiec.gov/nicpubweb/nicweb/nichome.aspx. A search for "United California Bank" will result in two matches with the following histories:

2/24/1961 California Bank renamed United California Bank

6/1/1981 United California Bank renamed First Interstate Bank of California 4/1/1996 First Interstate Bank of California acquired by Wells Fargo Bank, NA

First Interstate Bank and Wells Fargo Bank failed to protect the name "United California Bank."

7/2/2001 Sanwa Bank California renamed United California Bank

4/1/2002 United California Bank acquired by and merged into Bank of the West

Bank of the West is the successor to Sanwa Bank California which was renamed United California Bank in 2001 and maintained that name only until it was acquired 9 months later by Bank of the West. Any ownership interest in the name of United California Bank created during a period other than that 9 month period relates back to what became First Interstate Bank of California which was succeeded by Wells Fargo Bank, NA. Any interest succeeding from an interest created in the 1960s would now be Wells Fargo Bank, NA's, not Bank of the West's.

Attached are Certificates of Merger showing the mergers from Sanwa Bank California to Bank of the West that evidence what I've described above.

Please let me know what more I can do to show that Bank of the West is NOT an appropriate party to this proceeding and has neither the right nor the obligation to participate in the development or execution of a plan as you have requested.
