Mr. Dunn,

There are three issues with completing review of your submittal:

- 1) The document must be submitted to the ACEH ftp site in order for the document to be accepted by this agency. I have attached the rejection notice sent by the ACEH administrator for the ftp site which identifies the reasons for the rejection. I have also attached the instructions for document submittal.
- 2) I am attaching the December 27, 2011 Request for Regulatory Oversight Funds from our Division Chief which indicates that the current balance for this case is negative. In order to continue work on this case, submittal of the requested deposit is required.
- 3) Technical submittals for various cases are generally reviewed in the order received. Due to the heavy case load, we cannot meet requests to complete reviews by a specific date.
