Dear Ms. Sedlachek and Ms. Sime,

I am sorry but the required work on the Regional Board's closure reviews and closures themselves due to Resolution 2009-0042 has precluded me from reviewing your work plan in the usual 60 days. If you decide to implement your work plan, you would be doing so without concurrence from ACEH. If no comments arise from the review of the work plan, then proceeding with the work would not appear to have any significant repercussions. However, if comments to the work plan are identified, modifications to the fieldwork may be necessary, which may require additional mobilizations and/or additional sample analyses, etc. Please note that the UST Cleanup Fund typically reimburses costs for a scope of work that has been approved by a regulatory agency. Since a review of the work plan cannot be completed in the time frame allotted and if the scope of work is implemented prior to regulatory approval, the UST Cleanup Fund may not fully reimburse all costs associated with the proposed scope of work or remobilizations. Please contact the UST Cleanup Fund to address cost reimbursement concerns.
