At the request of ExxonMobil Environmental Services (EMES), on behalf of Exxon Mobil Corporation, Cardno ERI is notifying you of upcoming on-site activities scheduled for the week of January 30, 2012. Cardno ERI will be conducting an air sparge/soil vapor extraction feasibility test on the newly installed wells (SVE1 through SVE3, and AS1). This work is expected to take approximately two to three days to complete and will require a truck, remediation trailer, and holding tank to be on site. The locations of the proposed wells are shown on the attached Generalized Site Plan.






