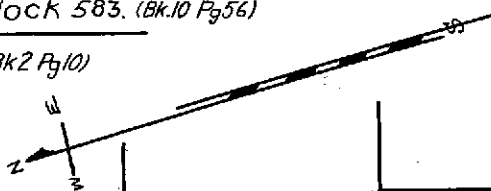

Map of Subdivision of a part of Block 583. (Bk.10 Pg.56)

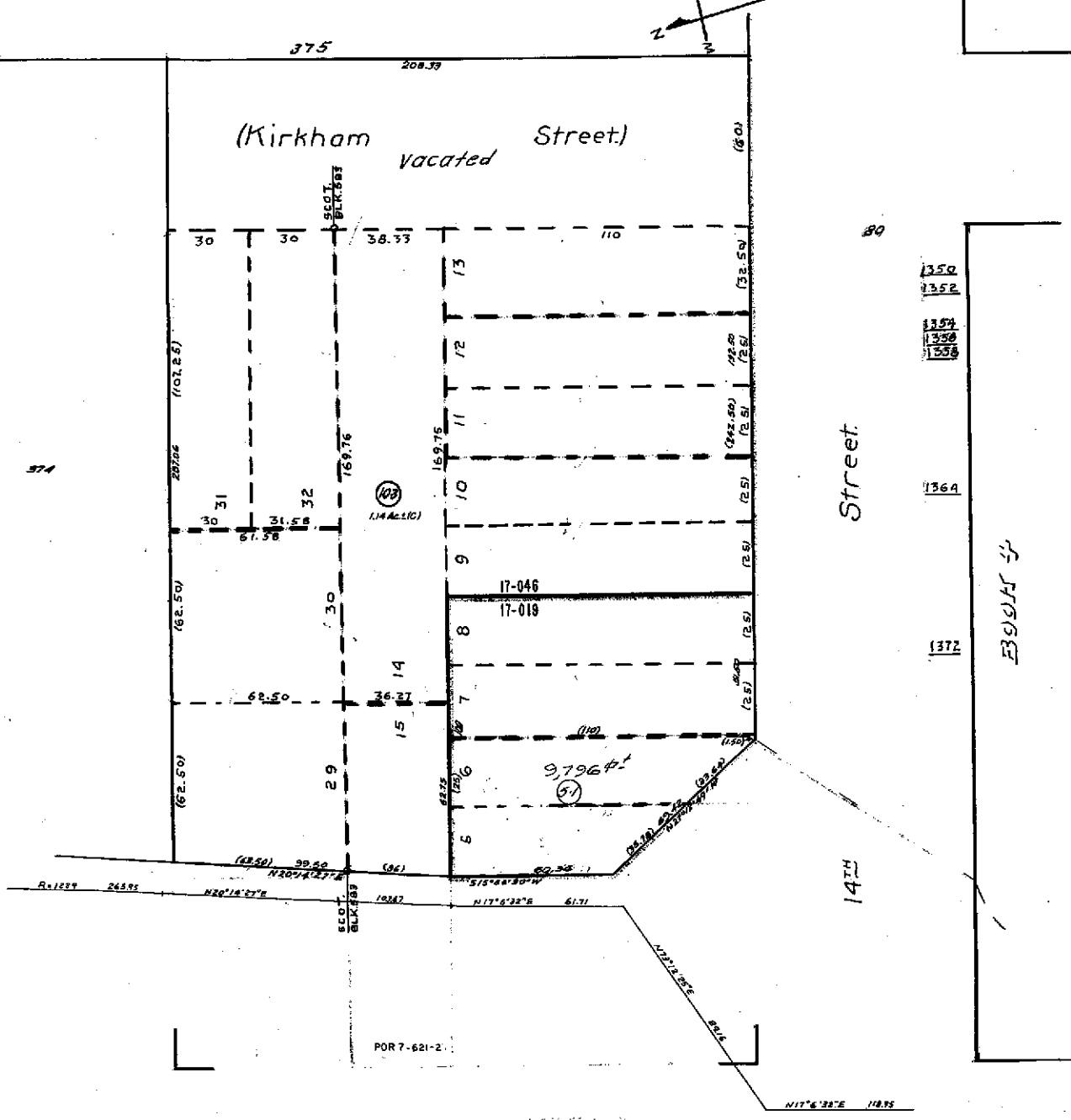
Map of the Scotchler Tract. (Bk.2 Pg.10)

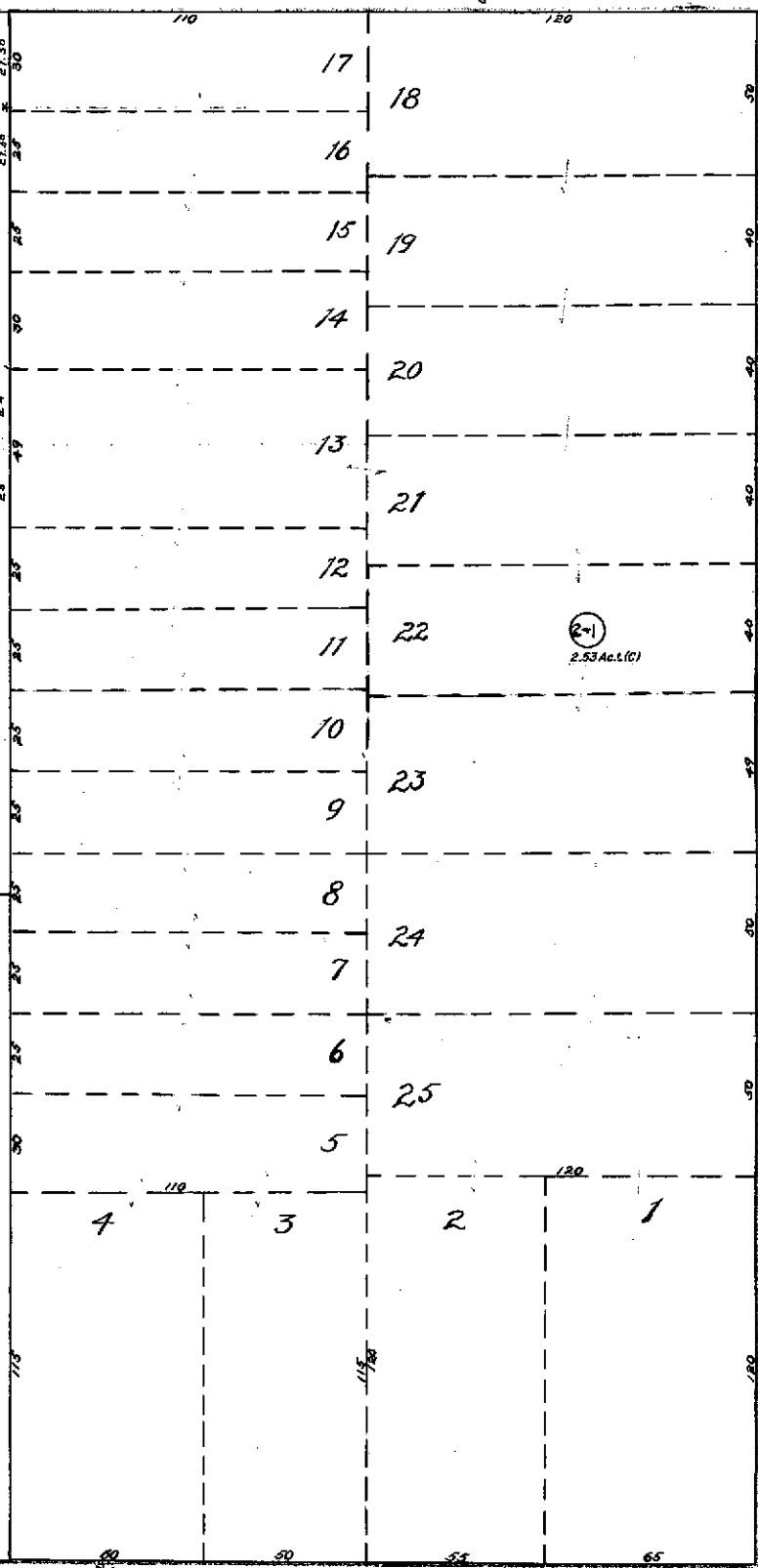
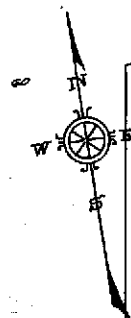
