Dear Responsible Parties:

The subject case is administered as a Site Cleanup Program (SCP) case by Alameda County Department of Environmental Health (ACDEH). ACDEH administers SCP cases under the authority of H&SC §101480 and establishes a deposit/refund account as authorized in Alameda County Ordinance Code §6.92.040L. In our letter dated June 16, 2017, you were notified the deposit/refund account was in arrears \$14,560. Knowing this and as a measure of good faith, ACDEH continued to work this case, conditionally approving a work plan on June 30, 2017. The case is currently \$15,831 in arrears.

As an RP, you are required to maintain sufficient funding in your deposit/refund account to cover regulatory oversight costs related to site assessment and remedial actions necessary to protect human health and the environment. Please submit payment in the amount of \$20,000.00 within thirty (30) days to the attention of our Finance Department. Please write "SCP" (the type of project), case number "RO0002981," account number "AR0322835," and the site address on the check. Failure to submit funds may result in referring this case to the Office of the District Attorney and/or Collections. Please send your check to the attention of our Finance Department at:

This deposit may or may not be sufficient to provide all necessary regulatory oversight. ACDEH will deduct actual costs incurred based on the Ordinance specified hourly rate, which is currently \$174.00 per hour. If these funds are insufficient, an additional deposit will be requested. Otherwise, any unused monies will be refunded to you or your designee.
