I am writing to inquire about the status of our case listed above. We are coming up on the 2 year anniversary of the removal of two underground storage tanks and one above ground storage tank, and I am curious to see where we are in the process to have this site closed.

In addition to removing the tanks, after receiving a request from the Oakland Fire Department, we have also submitted a Preferential Pathway Survey and Site Assessment Work Plan per your request, that was completed on July 28, 2009. This report was prepared by Ninyo & Moore Geotechnical & Environmental Science Consultants Project No. 401559001.

I realize we have spoken a few times in the past year, and I appreciate your help with my questions, particularly in relation to our company's application to the California UST Cleanup Fund. Due to a personal, family situation, we will have to put this building up for sale this year, which leaves me in an uncertain position.

I have been advised to wait until this site is closed by your organization and we receive a letter of "No Further Action," before listing this property. It is my hope that this will be the outcome, since in removing the tanks we followed the recommendation of the OFD, Gribi and Associates-our environmental consultant at the time, and Golden Gate Tank Removal to excavate, remove and dispose of 56.93 tons of contaminated soil and replace it with 56.93 tons of clean imported backfill. Our company has followed all of the requirements set before us in a timely manner and we our now hoping to close this chapter regarding the underground storage tanks.

Again, I realize you have been thrown a few curves this past year, with additional requirements requested by the City of Oakland, which forced you to set aside your regular duties. However, I am hoping that we can soon see the closure-hopefully with a favorable outcome, to the fuel leak case listed above.
