# Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

# Existence of Unauthorized Release

The site is an active retail gasoline service station located at 3750 International Boulevard in Oakland. Five soil borings were advanced at the site on August 5 and 7, 2008. Groundwater grab samples were collected from each of the five soil borings. Total petroleum hydrocarbons as gasoline (TPHg) were detected in three of the five groundwater samples at concentrations ranging from 180 to 3,900 micrograms per liter ( $\mu$ g/L). Benzene and MTBE were each detected in one groundwater sample at concentrations of 17 and 5.8  $\mu$ g/L, respectively.

#### Responsible Party Identification

Shell Oil Products US owned the USTs and property since April 1989. Shell Oil Products US is the primary responsible party because Shell Oil Products US owned and operated USTs at the time of an unauthorized release (Definition 1), was the owner of property where an unauthorized release occurred (Definition 3), and had control of USTs at the time of or following an unauthorized release (Definition 4).
