My client has a site in Castro Valley that has a loan contingency attached to a Phase II comment that was made to seek regulatory closure for some found contamination. The site is a dry cleaner, six borings were advanced and only one soil sample (76 ppb PCE) had any contamination – that was directly under the former dry cleaning unit. Groundwater was sampled at each boring location – everything was ND except for the same location where soil contamination was found. Groundwater from SB5 was reported as 6.7 ppb.

My client can possibly lose a lot of money if we cannot find some answer to this bank requirement. I would be happy to send you the Phase II report by AEI for you to review, and possibly receive a letter that there is no regulatory concern.
