Dennis,

I have reviewed your laboratory results from soil sampling and Preliminary Removal Report. We have no objection to backfilling the excavation and to continue roadway construction.

Please document the tank removal and soil sampling in a Final Tank Removal Report that includes a description of the tank removal, excavation, confirmation sampling methods and detailed map of sampling locations, analytical results, and soil and tank disposal manifests and other documentation. Please submit the Final Tank Removal Report and an Underground Storage Tank Unauthorized Release (Leak) Form to Livermore-Pleasanton Fire Department and Alameda County Environmental Health.

Alameda County Environmental Health will require further assessment of the extent of soil and groundwater contamination from the leaking USTs. We anticipate this assessment can be completed in areas adjacent to and downgradient from the USTs. We expect to send a Notice of Responsibility and request for a Site Assessment Work Plan within approximately 60 days.
