This is Sunny Piedmont Dry Cleaners and is a SLIC. The primary contaminant of concern is PCE. I approved a work plan on October 6, 2011 to remediate contaminated soil from beneath the dry cleaning machines, sample soil and soil vapor with the caveat that they add soil samples near the sewer lines, at locations of elevated PID readings, and that they specify the soil vapor sampling procedures. They submitted a work plan addendum with a map on November 8, 2011 and I approved the locations on January 25, 2012. I am still waiting for the results report from them and based on the results either the site will be evaluated for closure or additional work will be requested.

It is common for chlorinated solvent sites to contain low levels of contamination in soil and groundwater and have very elevated vapor concentrations (very similar to a site Paresh has in Dublin). There are residences downgradient of the site and people that work in the adjacent buildings that we are concerned about. Actually, the soil level beneath the dry cleaning machine was above the environmental screening level for PCE and this last effort was suppose to remove that soil.
