Hi Ross -

I note that several reports were rejected from GeoTracker for the Crown Chevrolet site because "Data could not be found in analytical results or tables of provided reports." (See example in email string below.)

By way of explanation, we had been asked by Alameda County to provide data for some third party reports that were recently prepared about the Crown site, but not on behalf of Crown Chevrolet, and not under regulatory oversight (i.e., due diligence investigations). Our understanding, based on speaking with Hamid at GeoTracker, was that it is not necessary to post these reports or data on GeoTracker. However, to comply with Alameda County's request, we hoped to add the field points and the data, but not post the full PDFs of the reports, as they were not prepared by or for Crown Chevrolet or pursuant to a regulatory request and contain some opinions that Crown may not support.

Please let me know if there is a better way to go about this, so that the data is available, but the text of the report is not. I think there are also a few other EDFs that were uploaded that may fall into the same category, for which we have yet to receive a rejection email.

Hi Avery,

I've received the GEO_BORES and EDFs that were submitted most recently. There are three remaining denied EDFs on GeoTracker and they are as listed below:

- 1) Excavation Confirmation Soil Samples and Groundwater Samples (confirmation # 2231229424)
-These samples were listed as water, but were actually soil samples. The EDF should be re-submitted as soil data.
- 2) 720-35684 (confirmation # 1196350038)
-I couldn't find the soil data point IDW-1 (Investigation-Derived Waste), which is a metals analysis for waste characterization. The easiest thing to do would be to re-submit this EDF without the IDW-1 data.
- 3) 720-35685-2 (confirmation # 6572824060)
-There is only one data point in the EDF, which is a soil sample labeled SUMP-5.0 and analyzed for motor oil. I couldn't find this data point either. If you could clarify what this data point is and where it could be found that would be great.
