Mark,

This message is to request an extension to the June 2, 2017 due date for submittal of a well destruction report included in your January 17, 2017 letter (letter was received on April 20, 2017). A permit packet, including associated fees, was submitted to the Alameda County Public Works Agency on May 8, 2017, but was not received until May 15, 2017. To date, we have not received a response to our well destruction permit applications which include justification for well

destruction by pressure grouting. After the permits are received, and the well destruction method approved, the drilling subcontractor will be scheduled, the work performed, and the report prepared. We are requesting an extension to the June 2, 2017 due date until July 28, 2017 to allow sufficient time for well destruction and documentation. Thank you for your consideration of this request for extension.
