I am in receipt of your letter dated July 12, 2010 regarding the above referenced Fuel Leak Case. I have attached a copy of your letter for reference. The purpose of this letter is to inform you of our progress in resolving the issues.

In as much as we will not be able to meet your deadline of August 16, 2010, I wanted to inform you that we are currently seeking bids from qualified consultants for a Phase 1 site assessment to determine if there are any sub-surface hydrocarbons present at this site, and if any additional work will be required to fully mitigate any issues that may be discovered. Furthermore, since leaded fuel was stored at this site, we will be requesting that the consultant investigate the potential presence of sub-surface lead.
