Mr. Detterman,

We have left a few voicemail messages for each other so I figured I would send you an email. Today ERRG sent Mr. Michael Lamphere (legal counsel for Apex Refrigeration, Inc.) a contract to conduct the soil and groundwater investigation related to the former UST at 1550 Park Avenue in Emeryville, CA. I've spoken with both Mr. Lamphere and Ms. Penny Barger and they are both concerned about the regulatory deadlines and being potentially ineligible for reimbursement from the State UST fund. Based on your email dated 7/24/12, and assuming the contract is executed in short order, ERRG would like to request an extension of the previous deadline to complete a Soil and Groundwater Investigation Work Plan for the site to **Friday, October 12, 2012**.
