Hi Brent,

In attempting to provide some accommodation to Ms. Mulholland, ACDEH had committed to proceeding without a work plan. Consequently, ACDEH had previously provided some detailed suggested bore locations that should help obtain the information needed to eventually close the case under the Low Threat Closure Policy. However, should she have considered to enter the UST CF, a work plan would not have been reviewed by an agency, and it is very likely the work would therefore not be reimbursable. I personally believe it unwise not to wrap everyone into the loop to make sure everyone is in agreement the work is what is required, but will leave that determination with Ms. Mulholland.

In regards to the private water supply wells, ACDEH does not have any information.  
Good luck with the project.
