This correspondence is to notify the Alameda County Department of Environmental Health (ACDEH) that we have recently been contracted by Mrs. Leslie Mulholland to prepare a Site Investigation Work Plan to assess the extent of contamination in shallow soil and potential impact to groundwater in the vicinity of the former 200-gallon underground diesel storage tank removed from the subject property in April 2010. The site investigation activities were requested by the ACDEH in correspondence dated March 8, 2016 and April 10, 2017, to obtain additional soil and groundwater data to determine whether the site can be considered a low risk case and eligible for closure under the Low-Threat UST Case Closure Policy.

We anticipate completing the site investigation work plan on or before August 25, 2017. As you well know, Ms. Megan Walsh, ESQ. has been assisting Mrs. Mulholland in completion and submittal of the UST Cleanup Fund claim application for future reimbursement of the corrective action costs associated with the site investigation activities.
