I cannot meet with you in the next few days until a case is opened administratively in our agency and my Supervisor signs off on the case assignment. I will try to take care of the approvals and administrative procedures tomorrow. Jerry:

Yesterday, I left you a very long voicemail regarding this subject site, and by now, you have hopefully received the March 10, 2011 letter from Danielle Stefani at the Livermore-Pleasanton Fire Department. I was hoping to talk and/or meet with you as soon as possible, maybe within the next couple of days. The property is currently being re-entitled for 50 new single family detached homes (Tentative Map was approved this last Monday night at Livermore's City Council) and

the property is scheduled to close within the next two months, so the old gas station and restaurant is obviously going soon. Unfortunately, I cannot get a financing mechanism in place without a "No Further Action" letter, and based on Stefani's letter, some further investigation will be needed, so as you can imagine, I'm under intense pressure to get this done.

I was hoping to meet right away so that we can discuss possible solutions that I can do immediately so that I can make you feel comfortable that the property has been cleaned up to the satisfaction of ACEHD. Time is unfortunately critical for me, so we are willing to be proactive in solving this matter now, rather than waiting. But here's what we know about the property:

- ~ We believe the affected areas are localized
- ~ There are 3 existing groundwater monitoring wells on the property now. They were installed and sampled in 1995. By 1996, after 3 quarters of sampling, only one sample during one event had a detectable diesel concentration. All other samples were non-detect. When 2 of the wells were sampled by ENGEO in 2006 (one couldn't be found), the water samples were non-detect for petroleum hydrocarbons. [Engeo can verify]
- ~ A Phase II (Exploratory) Environmental Site Assessment was done on the 3 UST's by Krazan & Associates in September 28, 2009. Even though ENGEO had found isolated (but elevated) concentrations of diesel in 2 soil samples in 2006, Of the numerous borings at the site (more than 10), only a couple of soil samples had trace concentrations of diesel. All other samples were non-detect for diesel and other hydrocarbons. [can provide you with this report]
- ~ The location where the 3 UST's and fuel lines used to be will someday be a neighborhood park [can show you the future site plan]
- ~ Per the Geotechnical Investigation by Engeo, Inc. (dated 10/21/10) much of the area around the location of the 3 UST's will have to be overexcavated up to 5 feet for compaction purposes [can provide you the report]

I know you are very busy, and I apologize for any inconveniences or difficulties I may cause, but I really need your help in solving this matter as soon as possible. Jeff Adams from Engeo, Inc. is working with me on this issue as well, and I have asked him to contact you also to help expedite this process. Please let me know if you have time to discuss/meet. Thank you! .....scott
