Hello Jerry, the soil excavation/removal at the Ashland Youth Center should be completed by this Wednesday. The deeper excavation and associated soil sampling in the northwest corner of the site is anticipated to occur tomorrow.

A second concrete vault was encountered today. This one and the vault encountered Thursday both appear to have water and sediment inside. The one encountered today also had a noticeable petroleum/solvent odor inside. Today we are collecting samples of the water inside the vaults for laboratory analyses. The material inside the vaults will be removed and placed into drums for off-site disposal and the vaults will be rinsed and removed, hopefully by the end of this week. We would like to discuss with you sampling requirements beneath the vaults. I'm assuming a minimum one soil sample beneath each one. Jacob Lee, our on-site geologist, will be there tomorrow if you are still thinking of stopping by.
