Delay at youth center site

Construction is stalled because of tainted soil

The long-awaited Ashland Youth Center Complex may not be completed ahead of schedule after all.

Construction on the facility has been stalled after grading work in mid-August turned up soil with diesel, motor oil and lead at levels higher than accepted standards.

The Alameda County Board of Supervisors on Tuesday approved increasing two contracts by a total of nearly \$1.2 million to analyze and remove the contaminated soil.

Chris Bazar, the county's development community agency director, said the proi-

ect already had a "significant contingency budget" because it was the former Holland Oil site at 16335 E. 14th St.

"It's a Brownfield site, and we knew there could be issues with it," Bazar said.

The former fuel depot. which closed in 1998, was purchased in 2008 by the Hayward Area Recreation and Park District in partnership with the community development agency. Money from the American Recovery and Reinvestment Act was used in the initial environmental cleanup of the site, where fuel from underground tanks had leaked into

The estate of Jack Holland Sr., the owner of Holland Oil, had no money to cover the costs, so the land became what the U.S. Environmental Protection Agency calls an "orphan site," with no finan-

cially responsible party left to

In June, supervisors approved a nearly \$13 million construction contract for the youth center with an estimated completion date of August 2012 - ahead of the original estimate of a late 2012 opening.

However, the construction firm had anticipated being able to begin work last month, after grading was completed.

According to county officials, it will take at least another three to four weeks to finish soil mitigation work, so construction might not begin until late this month. When completed, the campus will include a youth center along with the park district's new Jack Holland Sr. Park and a new multiuse gymnasium at Edendale Middle School.
