## Mike,

I received notification of a request for permitting 30 boreholes and 4 monitoring well installations for the Salvation Army site located at 601 Webster Street in Oakland, California. Presumably this is an additional phase of investigation following the execution of the work plan dated February 24, 2015, conditionally approved by Alameda County Environmental Health (ACEH) on June 1, 2015.

In our June 1, 2015 letter, ACEH requested receiving the analytical data from the hollow stem auger phase of investigation by August 28, 2015 and a review of the monitoring well data by September 24, 2015. To date ACEH has not received the analytical data for review and discussion. Please provide the data collected to date from the executed work plan, a figure of the proposed boring and well locations, and provide ACEH with a case status update. Please provide the documents via email by October 2, 2015.
