Hi Keith,

I apologize for misunderstanding the directive letter. It was not clear to us that the ACEH was looking for a response to all the questions raised prior to performing the work.

However, per your request (Item 3 of the directive letter), we did contact Beacon Environmental (the passive soil gas sampling vendor) regarding precipitation. Beacon recommended that we monitor precipitation data during the sampling and share the data with them. Based on the data Beacon may recommend extending the sampling period. They also stated this vapor sampling method was different than active soil sampling that is performed in a very limited time window. Because the sampling is performed over a long interval, the effect of relatively short duration rain events generally has a lesser impact on the sampling results. In addition it was noted that all of the areas to be sampled are covered with asphalt or concrete that would impede rain penetration.

We also apologize for the late notification. Please let me know if this response is adequate enough for us to proceed with the PSG survey.

Happy New Year. Thank you for the notification of field work, but it appears premature. I have nothing in my case file indicating I have received a response to Technical Comment 3 of our letter dated October 24, 2017. I've included a copy of the letter as an attachment. Please provide me with an update.

Perhaps I can't locate the correspondence as the ACDEH case file number is not included in the subject line.

Additionally ACDEH requested a 72-hour advance notification prior to the start of field activities. Though not explicitly stated, the 72-hour notification are for work days, not weekends and holidays. The county observes Martin Luther King Jr. day on January 15, 2018. Therefore at best your notification is 24-hours.

Please provide the requested information for my review. Following its receipt and review, ACDEH will contact you with regard to scheduling the PSG survey.
