Total petroleum hydrocarbons as diesel and oil were detected in subsurface soil samples collected during a limited site investigation at 1485 First Street in Livermore, CA. Based on this information, Alameda County Environmental Health (ACEH) has opened a Spills, Leaks, Investigations, and Cleanup (SLIC) case for the above referenced site. You are required to submit funds in order for ACEH to provide regulatory oversight of the case. We are requesting the submittal of a check made payable to Alameda County Environmental Health in the amount of \$6,000.00.

This deposit may or may not be sufficient to provide all necessary regulatory oversight. ACEH will deduct actual costs incurred based upon the hourly rate specified below.
