Regarding: LUST Site, 2700-23rd Avenue, Oakland, CA

Hi Mark,

I was recently informed that Donna is on vacation and you might be able to help with the 2700-23rd Avenue site in Oakland. I have attached relevant reports. The project started as a normal Phase 1 for a real estate transaction. It was discovered that a gas station was formerly on the subject site. Phase II Subsurface Investigations indicated that the fuel tanks and associated piping were removed, on-site soil contamination appeared not to be major, but significant groundwater contamination by TPH-g and benzene exists. Based on the contamination encountered, it was my recommendation to transfer the case from the Oakland Fire Department to the ACEH's Local Oversight program. The former on-site gasoline service station was a Tidewater Oil Co. facility which, over time, was absorbed by Chevron, who should be one of the responsible parties. The seller of the property has an agreement with the buyer (the current owner) regarding the responsibility for the cleanup of the contamination. A legal dispute has developed between the two parties and it would be helpful if the ACEH would take the lead of the environmental investigation.
