Dan/Peter, I thought I should give you an update on the schedule for the remediation plan as I have in place with CES and Envirosery.

- Tuesday 10/30/12, CES to make an access point into the basement on its east side in order for Enviroserv to get to the transformer area and assess what they will need logistically to remove the transformers and over packs with stored waste currently there.
- Wednesday 10/31/12, Enviroserv to remove transformers and over packs from basement area. Also, perform soft demo into drums/over packs on surrounding drywall partitions, and other contaminated construction material.
- Thursday 11/1/12, Complete soft demo containment and remove all materials and over packs. Place plywood protection over effected concrete floors and walls for demo and abatement after balance of basement is demolished.
- Concrete and soil related remediation activities to be scheduled when basement structure is removed around this area.

I am not personally familiar with whatever inspection and/or oversight will be required for this work, if any. Please advise immediately if someone feels there is an issue with performing these activates as scheduled. Thanks. db
