Hi Jeremy:

We have reviewed the revised TCE Evaluation report for RO0000008 and the Additional Characterization report for RO0003112.

We generally concur with the recommendations for closure of RO0003112. Therefore we will proceed with initiating case closure.

We also generally concur with the approach and evaluation provided for the TCE plume associated with RO0000008. However, we noted in our review that requested information on the foundations of buildings in the downgradient footprint were not provided. Please include this data in a letter memorandum with an accompanying figure and an evaluation of whether the foundation data changes the conclusions of the recommendations presented in the TCE Plume Evaluation report.

Karel will send you a Directive Letter tomorrow requesting completion of the landowner form and distribution of the public participation notice for RO0003112. You may proceed with public notification for RO0003112 separately or wait until you have provided the requested documentation for RO0000008 and we have concurred with closure and then send out both notices together. The addresses Karel will send you can be used for both cases.
