As we discussed yesterday, the above site is being referred to you for follow-up. The analyses reports were mailed to you yesterday. You advised that a water sample needs to be taken and specific fill material needs to be used to temporarily close the pit.

This pit is a 17' foot hole in the sidewalk in front of an apartment building. It is barricaded and covered with wood however it is a potential hazard and we would like the pit filled in as quickly as possible. Can you please provide Golden Gate and the property owner with instructions for taking the water sample and materials they need to use to temporarily closing the hole.
