All, I have engaged an appropriately licensed firm-Dan's Water Well Drilling to complete the removal of the SVT. After some research it appears that TecAccutite, the original UST removal contractor installed the SVT without obtaining the requisite permit. Insofar as we are no longer the property owner I apparently cannot pull such a permit. This can only be done by the property owner or a licensed contractor. The aforementioned contractor will obtain the permit only upon being supplied with a plot plan that includes an accurate depiction of the SVT site location. In order to do this I must obtain a plot plan and then measure the site location accurate to the property boundaries. To do this I need access to the property by way of being supplied with permission to enter including the access code as the property is gated. I will then use a wheel measure to prepare an accurate site plan for the drilling contractor. As I think all are aware we are in litigation with TecAccutite over this whole matter with a resulting in an adversarial relationship and can expect no cooperation from them. As of the moment I am out of town until October 9. Upon my return it is my intention to take the necessary steps to create the aforementioned drawing and supply it to the contractor so they can pull the permit. Lastly, the contractor will need the gate access code as well as the cooperation of the property owner to allow them unfettered access to the site to complete the work. By this email I am requesting the gate

code for access to complete this task so that we can hopefully bring this matter to a satisfactory conclusion. Marc Silvani.

Alameda County Environmental Health (ACEH) understands that Mr. Marc Silvani, the former property owner, is awaiting approval of the access agreement to allow the drilling company onto the property to decommissioning the soil vapor well SVP-1. Please sign an access agreement with him so that the well can be destroyed under permit. ACEH cannot close the case without the decommissioning of the well and the submittal of a report documenting the action. The report must to be signed and stamped by a California registered geologist or engineer. After ACEH receives a complete Well Decommissioning Report, ACEH will have 30 days in which to issue the Closure documents and close the case.
