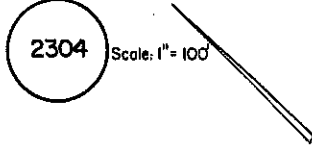

ASSESSOR'S MAP 34

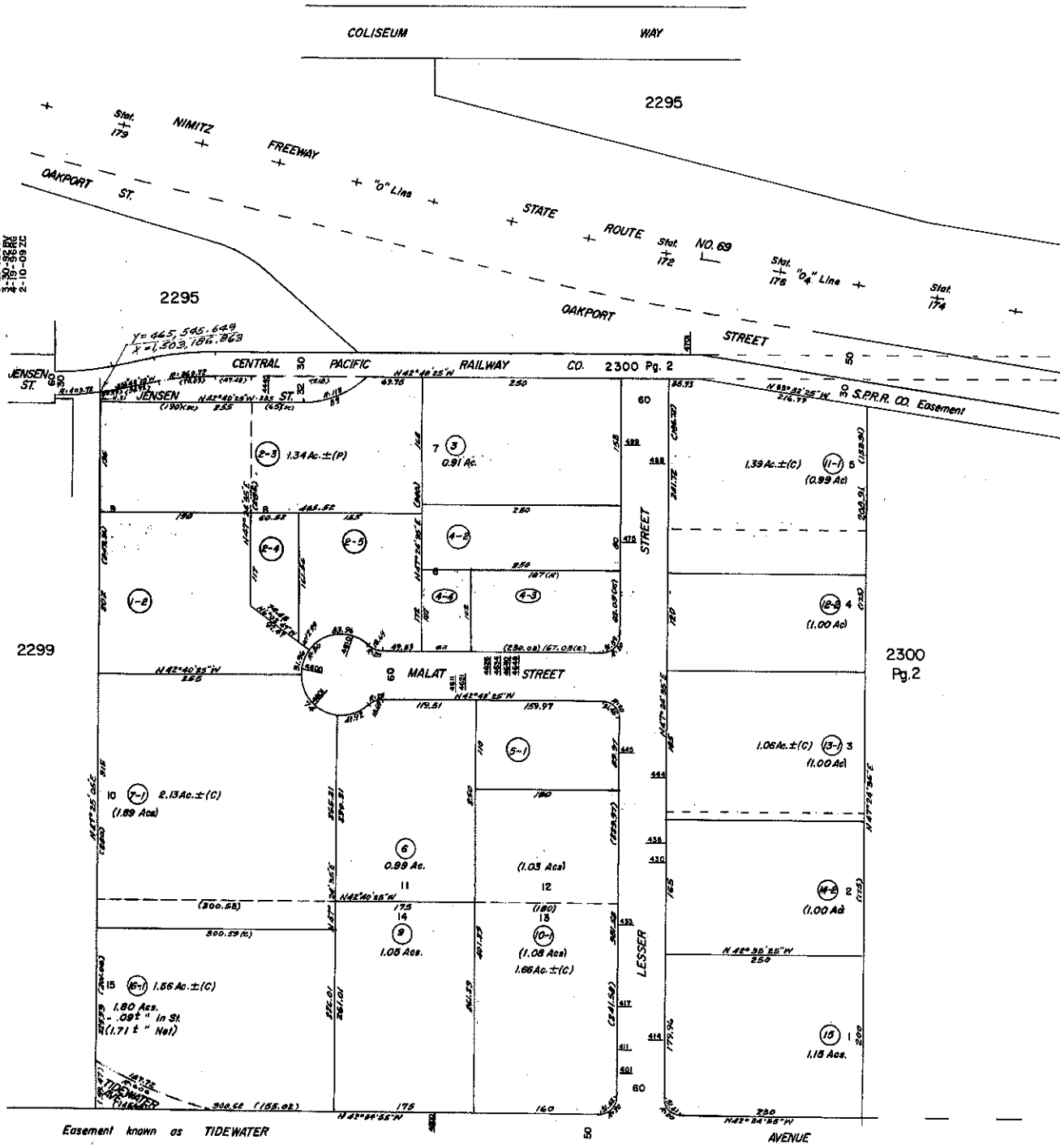
