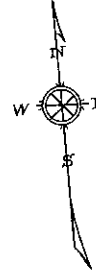

Map of the Shepardson Property. (Bk. 2 Pg. 48)

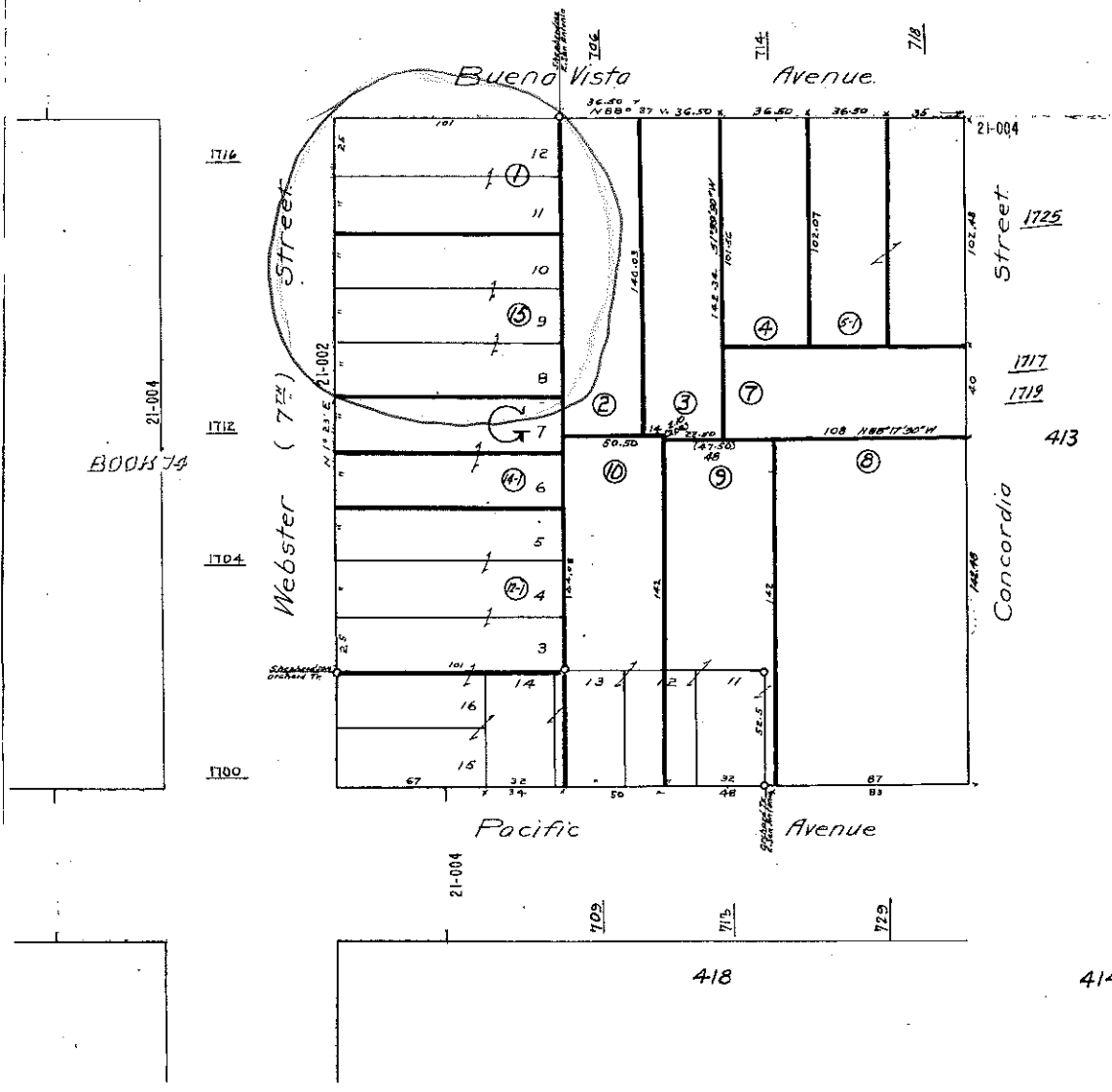
