Dear Mr. Murray:

The referenced site is a SCP case due to the presence of soil and groundwater contamination at the property. Alameda County Environmental Health (ACDEH) is the agency providing regulatory oversight for this case. Funds for regulatory oversight in the SCP Program are provided directly by the property owner or other responsible parties. In order for ACDEH to complete the regulatory review and closure process, ACDEH requires a deposit to an oversight account. It has been nearly a year since the previous request, and multiple investigatory actions have occurred at the subject site, requiring multiple reviews and meetings. At present there is approximately \$450 in unrecovered expenditures that have accumulated at the site. Consequently please send a check in the amount of \$6,450.00 payable to ACDEH. Please send your check to the attention of our Finance Department; copied below.

This deposit may or may not be sufficient to provide all necessary regulatory oversight. Funds received by ACEH for SCP cases such as yours, are held in a deposit/refund account. The deposit/refund account is charged on an hourly basis as case work is performed. If these funds are insufficient, an additional deposit will be requested. Otherwise, any unused monies will be refunded to you or your designee.

The deposit is authorized in Section 6.92.040L of the Alameda County Ordinance Code. Work on this project is being debited at the Ordinance specified rate, currently \$174.00 per hour. Please write "SCP" (the type of project), account number "AR0341893", and the site address on your check.
