Julie.

I wanted to followup on the Standard Operating Procedures (SOPs) you provided, and in lieu of responding in a directive letter, I am providing comment in this email, so that you can move forward on the project. Please note these comments carry the same weight as a directive letter.

- 1. Sub-Slab and Soil Vapor Sampling Helium was proposed to be used during the collection of these samples; however, this comment extends to other tracers as well. Helium was proposed as a tracer to determine if a leak of atmospheric air is present that could dilute the vapor samples, during the collection of these samples. In addition to analysis for helium, or other tracers, in the sample, please additionally collect a shroud tracer concentration in order to determine if the potential leak exceeds the DTSC allowed 5% dilution rate.
- 2. Indoor Air Sampling Eight-hour indoor air samples were proposed in the SOPs. In conformance with DTSC guidance, ACDEH requires samples to be 24-hour samples for the determination of human health risk. Eight-hour samples are appropriate for repeat events for checking changes in indoor air concentrations. ACDEH views the requested resampling in the dentist's office (also labeled a baseline) as an evaluation of the human health risks associated with elevated vapor concentrations in the suite.
- 3. Air Monitoring Cal-OSHA PELs were proposed for air monitoring action levels. These may be appropriate for site workers trained in HAZWOPER operations; however, alternative action levels for offsite workers (restaurant, dentist office, etc.) are appropriate. Because women of child-bearing age without respirator protection may be present at offsite locations, more stringent action levels appear appropriate. Prior to approval of excavation, please identify appropriate offsite action levels.
