Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

Responsible Party Identification

Existence of Unauthorized Release

On November 25, 2014, one 1,000-gallon underground storage tank (UST), related product piping, and dispenser were removed from the site. The UST historically contained either gasoline or diesel. The Underground Storage Tank Closure/Removal Field Inspection Report noted that the tank was corroded, obvious soil discoloration and odors were noted in the tank bed, and holes was observed in the tank. During tank excavation, concentrations up to 106 milligrams per kilogram (mg/kg) ethylbenzene, 48.3 mg/kg total xylenes, 497 mg/kg Total Petroleum Hydrocarbons as gasoline (TPH-g) were detected in soil taken from beneath the UST at depths of 7.5 and 8 feet below ground surface. These data indicate that an unauthorized release occurred at this site.

Responsible Party Identification

Neishi, Dan S. Trust & Neishi, Mitsugi Heirs of Estate, et al. (aka Neishi Brothers Nursery) purchased the property, or acquired the title, on July 18, 2012 and Neishi, Dan S. Trust & Neishi, Mitsugi Heirs of Estate, et al. (aka Neishi Brothers Nursery) is a responsible party because they owned or operated an underground storage tank used for the storage of any hazardous substance (Definition 1); they currently own the property where an unauthorized release has occurred (Definition 3); and they had control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance (Definition 4).
