Thank you for the reports uploaded to the State Water Resources Control Board's (SWRCBs) GeoTracker website. Due to the condition of the reports, they did not meet the Alameda County Environmental Health (ACEH) FTP website requirements and were rejected. I have downloaded the reports from GeoTracker and placed them in the queue for upload to the ACEH FTP website.

The Building Plans submitted to the City of Oakland and provided to ACEH as a zip-file was deleted as the files were rejected by ACEH. Please provide the plans to ACEH- attention Keith Nowell as an email attachment (send to keith.nowell@acgov.org).

A brief review of the reports found a reference to a Phase II Environmental Site Assessment (Ph II ESA) report prepared by McCulley, Frick and Gilman (MFG) and dated June 29, 1996. The reports requested in ACEH correspondence dated April 23, 2015 have been uploaded to the ACEH and Geotracker Websites. The reports prior to 2014 were supplied by the property owner, not the developer (City Ventures). The March 14, 1994 Phase I Environmental Site Assessment Report being submitted is listed as partial because that part of the report is the only portion which was supplied to us for review – we cannot provide a discussion of the documentation missing from the report because we have not seen the whole report.

Also included in the ACEH upload is a zip-file with the Building Plans submitted to the City of Oakland for entitlements in March of this year. The project consists entirely of at-grade, townhome-style residential condominiums over private garages and/or retail (the latter at W. Grand and Market). There will be no subterranean garages, elevators, basements or other subsurface improvements of note. The W. Grand site is currently (post demolition) depressed relative to adjacent sidewalk elevations, and thus, we expect to import approximately 8,000 CY of clean, engineered fill to raise the site prior to vertical construction.
