Per our phone conversation on March 15, 2017 discussing potential table errors, Alameda County Department of Environmental Health (ACDEH) could not locate an EDF for samples collected on May 30, 2014. Please verify its submittal. Additionally, ACDEH could not verify the benzene concentration for sample SV-4 as identified in Table 3. By the date specified below, please identify the EDF submittal which supports the SV-4 benzene concentration and provide the Stantec report name and page number containing the results in the laboratory analytical report for SV-4.

As discussed in our phone conversation referenced above, by the date specified below, please identify the table and page number where the results for sample SV-12 DUP can be located.

Re your last sentence regarding having missed anything: as stated in our letter dated October 20, 2015, ACDEH is not a proof reading agency. Your question is best addressed to your project manager.

A search of the California State Water Resources Control Board (SWRCB) GeoTracker database did not locate a site for the case identified in your subject line and it is not familiar to our agency. We request that future correspondences to our agency include, at a minimum, the ACDEH case file number in the subject line.
