Thank you for your comment on the proposed soil remedial action at 2868 Hannah Street in Oakland. Following review of all comments from the public and Alameda County Environmental Health, the responsible party has modified their plans for soil remediation at the site. I have attached a document entitled, "Soil Remedial Action Plan Amendment," dated January 8, 2016, which describes the revised plan for soil remedial action. The plan includes excavation and off-site disposal of contaminated soil. On-site aeration of contaminated soil is no longer considered as part of the remedial action. We have requested that the responsible party prepare a Fact Sheet that describes the modified plans. After review and approval by Alameda County Environmental Health, the Fact Sheet will be distributed for public comment at a future date. The entire case file can be viewed over the Internet on the ACEH website (http://www.acgov.org/aceh/lop/ust.htm) or the State of California Water Resources Control Board GeoTracker website (http://geotracker.waterboards.ca.gov).

Good morning Jerry:

The discussions about remediation at this property seem to be premature as I see no permit or discussions with the Bay Area Air Quality Management District. Has the BAAQMD been notified of the proposal and have they authorized and permitted this process?

PERC is a substancial hazard to our community and the BAAQMD has jurisdiction over the air release of this material. Remediation by evaporation has not been allowed in the past except except for removal of dry cleaning equipment under specific guidelines - soil removal or carbon bed processing is used instead - but these methods were in place before PERC usage was outlawed and removed from the source inventories.

Soil removal has the least impact on our community. Please investigate this issue further before allowing the operation to proceed.
