Dear Mr. Hester:

Alameda County Environmental Health (ACEH) understands that Mr. Francis Rush with 2868 Hannah Street & Precision Lofts, LLC (Precision Lofts) and Mr. Dave DeMent with Environmental Risk Services Corp. (ERSC) have requested access to your property at 2851 Helen Street in Oakland to conduct a subsurface investigation. Mr. Rush and Mr. DeMent have informed ACEH that access has not been granted since you have not responded to their written request for access to your property. The purpose of this letter is to advise you in your decision regarding access.

A suspected hydrocarbon release has occurred at the 1549 32nd Avenue property and has contaminated the soil and groundwater beneath the site. As the responsible party, Precision Lofts is required to investigate the extent of the release(s) and to clean up the contamination. These requirements are set by the State and this Agency provides local oversight for compliance with these laws. For this reason for Precision Lofts and ERSC (Precision Loft's Environmental Consultant) have requested access to determine the extent of the contamination that may be beneath your property and perform the cleanup as necessary, thereby complying with State law as required by this Agency.

ACEH encourages you to work with Precision Lofts and ERSC and agree upon the terms necessary (i.e. your signature on the access agreement) to allow them access to your property to conduct the subsurface investigation. If you decide to deny access or do not respond by the date specified below, and if the release does affect your property, then this Agency and the Regional Water Quality Control Board may hold you legally responsible for the contaminated condition of your property. You may then be required to conduct remedial investigation of the contamination at your own expense. Since the costs for such investigations are often high, allowing access to Precision Lofts and ERSC is clearly more reasonable. Please respond to the access request previously sent by Precision Lofts and Environmental Risk Services Corp. within thirty (30) days from the date of this letter (August 25, 2008).
