You may have received a notification that the GEO_REPORT and an EDF were denied in GeoTracker pending GEO_MAP submittal. I have made a precursory review of the GEO_REPORT and observed there is no lab data for samples WC-1 through WC-6 in the GEO_REPORT though the data is used in the mass removal calculations. Additionally, there are no manifests to document disposal of materials removed from the site.

Please include the disposal manifests for material removed for off-site disposal and the lab data for WC-1 through WC-6 in the GEO_REPORT. Additionally, please upload the EDF for the WC-1 through WC-6 analysis.

I look forward to reviewing the revised GEO_REPORT upon its upload to both the GeoTracker and Alameda County Environmental Health (ACEH) ftp websites. The GEO_REPORT review will require the submittal of the GEO_MAP and the WC-1 through WC-6 EDF analysis data in order to perform an adequate GEO_REPORT review.
