1. 1607 2nd Ave, LLC. is the only entry required so long as they are the sole current property owner.
2. It is appropriate to leave off duplicates in the distribution list as the duplicate listing need only be contacted once.
3. Additionally addresses to be included are those which are within the selected parcels but whose addresses do not appear on the list. Generally, this would apply to apartment complexes where all the units may not have been identified.
