Dear Mr. Rosequist:

During the removal of a 500-gallon home heating oil tank from 947 Hillcroft Circle, holes were observed in the tank and a petroleum odor was observed in the soil. Two soil samples collected from the tank excavation contained 595 and 634 milligrams per kilogram of Total Petroleum Hydrocarbons as diesel. Based on the evidence of an authorized release, a fuel leak case was opened for this site in June 2015.

Alameda County Environmental Health (ACEH) staff is currently reviewing this fuel leak case file for potential case closure. Pursuant to sections 25297.1 and 252917.15 of the Health and Safety Code, ACEH is required to provide a Notice of Responsibility for all fuel leak cases. To complete this requirement, we are also attaching a Notice of Responsibility to this letter. However, as previously discussed, the fuel leak case is currently under review for case closure.

List of Landowners Form

Pursuant to Section 25297.15 (a), Alameda County Environmental Health (ACEH), the local agency, shall not consider cleanup or site closure proposals from the primary or active responsible party, issue a closure letter, or make a determination that no further action is required with respect to a site upon which there was an unauthorized release of hazardous substances from an underground storage tank subject to this chapter unless all current record owners of fee title to the site of the proposed action have been notified of the proposed action by the primary or active responsible party. ACEH is required to notify the primary or active responsible party of their requirement to certify in writing to the local agency that the notification requirement in the above-mentioned regulation has been satisfied and to provide the local agency with a complete mailing list of all record fee title owners.

To satisfy this requirement, please complete the enclosed *List of Landowners Form*, and mail or e-mail it back to ACEH by the date identified below. Also your comments, if any, must be considered prior to the proposed closure. Please respond within 30 days from the date of this letter for your comments to be considered.

Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

Existence of an Unauthorized Release

A 500-gallon underground storage tank (UST) was removed from the front yard of a residence at 947 Hillcroft Circle in Oakland, CA on June 18, 2014. During the UST removal, holes were observed in the tank and a petroleum odor was observed in the soil. Two soil samples collected from the tank excavation contained 595 and 634 milligrams per kilogram, respectively, of total petroleum hydrocarbons as diesel. Based on these results, an unauthorized release or releases appears to have occurred from the former UST system at the site.

Responsible Party Identification

The Ronald V. Rosequist TR is a responsible party because they are current owner of the property where an unauthorized release occurred (Definition 3).
