Hi Denise,

I've spoken with Dilan briefly this morning about the project. Unfortunately she is not feeling well (has flue), and we'll need to push off a more detailed discussion. However, prior to ACDEH giving further approvals for the project, we need to understand the schedule for the entire project, including submittal of work plans and reports to investigate the undocumented fill and vinyl chloride soil gas concentrations. Please work with your consultants to revise your schedule in a Gantt Chart form to show all environmental activities including trench plug installation, CQA of the trench plug installation, vapor mitigation systems, including barrier installation and venting risers through the foundation and vertical construction of the building, CQA of vapor mitigation elements, and the submittal and review times for additional investigation activities. Dilan has indicated the Gantt Chart needs to show links to all interconnected activities and include appropriate review times for items needing approval by ACDEH. Once submitted, we would like to schedule a meeting to understand the schedule and the project so we all have a common understanding of the project. Thanks.

Denise, and all,

I am sorry for my delay in responding to your emails and phone messages. Between the holidays, and other sites that need IMMEDIATE attention I have not been able to respond as quickly as I or you would like. Regardless, I have reviewed the recently submitted *Trench Dam & Trench Plug Plan* (page C1.5 of the development plan set) that was approved by the City of Fremont on October 31, 2016. Based on the approved plan I believe that approval to proceed with the installation of the utilities is appropriate. This approval is intended to include site grading in the vicinity of Buildings 7 through 12; however, does not include construction of Buildings 7 through 12.
